Chairman's Report – Annual General Meeting 2024

Dear Members and friends of MAYCHAM,

We were happy to resume normal travels for our financial year, April 2023 to March 2024 which allowed us to organize more trips and also gave us opportunities to welcome friends from Malaysia and elsewhere.

One of the highlights was our 10th Anniversary celebration, graced by the presence of Hong Kong's Chief Executive, Mr. John Lee. The event was attended by approximately 800 members and friends, including foreign embassies and foreign chambers. We were honoured to have Mr. Lee deliver a speech, and the evening was filled with the finest Malaysian cuisine, making it a truly memorable occasion.

We made some very fruitful trips to Mainland China, to Hangzhou, Shantou and the Greater Bay Area. We were able to visit some very important places, such as Geely, Alibaba, Westlake University, BYD, Huawei and met with Chambers of Commerce in Shantou. These visits were made possible through the introductions of our members, and they provided valuable insights and networking opportunities.

I am pleased to report that Maycham achieved the highest surplus in our 10-year history, with a surplus of nearly \$1.3 million. This outstanding financial result has boosted MAYCHAM's funds to \$3.9 million, strengthening our ability to continue providing excellent services and support to our members.

Despite some members relocating elsewhere, we have successfully attracted many new and valuable members, contributing to the growth of our membership base. We are grateful for the continued support and trust shown by our members, and we remain committed to providing a vibrant and inclusive community for all.

For the Students Trust Fund, we continued to gain support from generous donors. The generosity of our donors remains instrumental in supporting the Students Trust Fund. During this financial year, we received increased donations totalling \$2.7 million. This additional support has allowed us to sponsor a total of 143 Malaysian university students in Hong Kong and Macau thus far, enabling them to pursue their academic goals and contribute to their communities.

The Nasi Lemak Talks Series continued to be a resounding success and we were honoured to have very notable speakers, Ms. Lim Kim See, Regional Director East Asia and Pacific of The International Finance Corporation (IFC, a unit of World Bank), Tengku Zafrul Aziz, Malaysia's Minister of International Trade and Investments and Mr Shen Wei Jian, Executive Chairman of PAG.

I would like to Thank all EXCO members and their subcommittee members, Advisory Council members, WiN Interest Group, including Students Trust Fund Selection Committee and MAYCHAM's General Manager Fenn Ho and Iris Cheung and all MAYCHAM members for their continuing support to make MAYCHAM a real SUCCESS.
